

## **Data Protection and Cookies Policy.**

This Data Protection and Cookies Policy includes the data processing processes carried out through the use of the Internet and other electronic communications networks by Camping Fuente de la Teja. For any request related to your personal information or query related to these practices, please contact the data protection officer at the address [camping@fuentedelateja.com](mailto:camping@fuentedelateja.com). Keep in mind that all data collected by this means will be processed and kept in accordance with Spanish legislation and the provisions of the General Data Protection Regulation (RGPD) (Regulation (EU) 2016/679).

Personal data is defined as any information that allows the identification, direct or indirect, of a natural person. This information may include your name, email address, your computer's IP address, or an identification number.

Personal data collected

When visiting this website we collect your personal data when you use:

- Online forms.
- Email hyperlinks.
- Content downloads.
- Contact pages.

The personal data we collect includes: first name, last name, email address, telephone number, company name.

Finally, when you email us with an inquiry, we also collect your personal contact details.

We process this personal data in accordance with Article 6 (b) of the GDPR, as we need this information to answer your query.

In addition to the above, we automatically collect data about your visit to our website. For more information on this matter, see the section "Use of cookies" that is available later.

Processing of personal data

## **Period of conservation of personal data**

We will not retain your personal data for longer than is necessary for the purposes of collection, unless required by law:

- Personal contact details: a maximum of 3 years.
- Cookies: a maximum of 13 months.

Your rights

### **Use of cookies**

Our website uses cookies. By accessing our website we will inform you, through a pop-up banner, of our use of cookies.

#### (1) About cookies

Cookies are files, often with unique identifiers, that web servers send to Internet browsers and can then be sent back to the server each time the browser requests a page from the server.

Cookies are used by web servers to identify and track users as they navigate through the different pages of a website, as well as to identify users returning to a website.

Cookies can be "persistent" cookies or "session cookies". A persistent cookie consists of a text file sent by a web server to an Internet browser, which is stored by the browser and remains valid until the defined expiration date (unless the user deletes it before the expiration date. ). On the other hand, a session cookie expires at the end of the user's session, when the Internet browser is closed.

(2) Cookies from this website

On this website, we use session and persistent cookies.

We will send you the following cookies:

1. Session cookies
2. Google Analytics: this cookie allows us to identify unique users, unique sessions, regulate the request rate and store information about user sessions and campaigns.

(3) How we use cookies

Cookies do not contain personally identifiable information, but we have the ability to link the personal information we store about you with the information obtained and stored from cookies.

We use the information we obtain from the use of our cookies for the following purposes:

- (1) Recognize your computer when you visit our website.
- (2) Improve the usability of the website.
- (3) Analyze the use of our website.
- (4) Manage the website.
- (5) Third-party cookies

When you use our website, third-party cookies may also be sent to you.

Our service providers may send you cookies. They use the information they obtain through their cookies for the following purposes:

3. Select specific advertisements that may be of interest to you.
